## INSPECTION SERVICE

In manufacturing world, it is very unlikely to find that a component is inspected after it is integrated in the product. The very idea of inspecting everything after completing all product development is a dangerous one – one that has many business and financial risks associated with it.

The process of our inspection service can be your biggest asset if we have invested early efforts in building quality and then inspecting it. Else, it can be a huge waste. Reduce this waste and you will automatically start forming a culture where "building quality" always takes precedence over inspecting. Your journey towards a quality-oriented culture begins there.

Following are some very simplified guidelines on how our inspection activity can be leveraged to generate value and lower risks for you our customers. Each one of these points can be a process in itself.

- Know customer's quality expectations early and educate team
- Clarify the exact customer requirements (and be ready for change)
- Give thoughtful consideration to a robust product design
- Plan actions to ascertain that quality expectations are built in the product
- Inspect Early and Inspect Often in cycles
- Each cycle of early inspection reduces risk of failure
- With this, final cycles of inspection can focus on "value-delivered-to-customer" rather than "defects-found-at-the-tail-end".

Here our quality inspection service including the following elements:

- ✓ Factory Audit(FA), It is important to verify that your supplier has the appropriate working condition, facilities, machinery, methods of a sufficiently high standard and a sound quality control system to meet the quality you demand. However, a manufacturer or importer, equally, need reassurance and advice on the capabilities of the current production:
- ✓ Initial Production / Sample Check(IPC), After the manufacturer has been chosen, we will undertake an inspection on every batch of all materials and components to be used for your product. In this IPC, material, components and the first few finished units are checked at the commencement of productions against your specification and approval sample. The IPC thus permits timely correction and improvement before the bulk of production is initiated.
- ✓ **During Production Check (DURPO)**, The DUPRO provides the on-line inspection, DQC qualified inspectors will check that the corrections and improvements suggested during the IPC were implemented, examine the existing productions, advised the manufacturers of any further corrections or improvements to be made.
- ✓ **Final PCS/PCS Inspection (FFI)**, The pre-shipment inspection takes place when the merchandise has been 100% produced, we inspector then check PCS/PCS before it is packed, We check on material, quantity, workmanship, function, colour & style, size specifications, packing details and shipping marks, all with a view to ensure that the

contract specifications are met.

✓ **Supervision of Loading (L/S)**, This service is offered at the manufacturer's premises, warehouse or forwarder during containerization after our Finial PCS/PCS Pre-shipment Inspection, This service ensure that a lot is being shipped in proper condition and in its entirety. When the lot is to be shipped by container, we first examine the container itself, ensure the container is safe and clean, then ensure that the stuffing operation is carried out properly, namely that pallet / cartons are securely stacked and not mishandled.

Our rate of Inspection Service, this is mainly based on the quantity per month and the number of manufacture.
